**BYLAW NO. 798**

Being a bylaw to amend the "Village of Ashcroft Solid Waste Removal and Disposal Bylaw No. 785, 2013"

---

The Council of the Corporation of the Village of Ashcroft in open meeting assembled, enacts as follows:

1. That Bylaw No. 785, cited as "Village of Ashcroft Solid Waste Removal and Disposal Bylaw No. 785, 2013" is hereby amended as follows:

The new wording for Section 47 is as follows:

Old age pensioners, and others who qualify for the additional Home Owner Grant, may upon application receive a reduction of the solid waste bill for a single family residence. This discount will be available in accordance to Schedule "B"

Homeowners who qualify for the Home Owner Grant for Persons with Disabilities or who qualify for the home owner grant and receive the Federal Seniors' Guaranteed Income Supplement, may upon application receive a reduction of the solid waste bill for a single family residence. This discount will be available in accordance with Schedule "B".

"Schedule B" be attached to Bylaw 785.

2. This bylaw may be cited for all purposes as "Village of Ashcroft Solid Waste Removal and Disposal Amendment Bylaw No. 798, 2015".
