



Hockey & Curling Update

In preparation of those chilly months, the Village crew has been busy putting ice in the arena, like so many other facilities during the pandemic, things are quite different. Arena operations will be limited to Minor Hockey skill development, practices and limited games. Staff is working with the Thompson Cariboo Minor Hockey Association to ensure kids hockey continues and they are able to get on the ice; sadly, public skating or adult hockey will not be part of the arena operations this year. Notably, ladies, co-ed and Beer-belly leagues are disappointed with this decision. The decision was based on staffing levels and safety, facility amenities including dressing room capacity and meeting WorkSafeBC regulations were the primary difficulties to overcome.

The ice has also been put in at the Curling Rink. On Tuesday November 3rd the Curling Club officially opened the rink to curling with stringent COVID-19 safety regulations in place. The new chiller is working well and the ice is keen!

The curling club welcomes new curlers and invites anyone interested to stop by and give it a try!

Trails

The ongoing issue of the walking trail along Evans Rd. continues to be a concern for the Village. We fully understand the desire to have a “river walk” however as administrators of the municipality, we must look at this from all angles and most specifically through the lens of public safety. The current pathway along Evans Rd. has been developed by a group of volunteers with the best of intentions; a river walk would certainly be a wonderful recreational addition to the community, that said, the development of trails and pathways must be undertaken with the approval of Council.

Recently, Council identified the strategic priorities for next year, the development of a Trails Master Plan is one of those goals. Staff is currently seeking quotes from experienced trail builders for the development of this plan. Having someone that not only develops trail plans but also builds and uses trails is a priority for Council. This individual will bring a new perspective and fresh eyes to



Ashcroft’s recreational trail opportunities, considering all existing trails and propose locations for new trails, trail heads and suggest ways to connect the three distinct neighbourhoods in Ashcroft. Stay tuned for future updates!

- Council Adopted Sign Bylaw No. 840

Council is in Favour of Hiring a Bylaw Officer

The communities of Ashcroft, Cache Creek and Clinton are exploring the possibility of implementing Bylaw Enforcement as a shared service in their communities. At this time a Working Group has been established consisting of one staff member and one Council member from each community. If implemented, the shared bylaw enforcement service will work in collaboration with local RCMP detachments working towards community bylaw compliance. A new bylaw will be required that supports ticketing and an appeal process. All communities are struggling to provide this service, the proposed collaboration may be the catalyst to other shared services in our

RV and Other Parking on Boulevards

The Village is receiving many complaints in regards to RV's and un-licensed vehicles parked on boulevards. Not only is this unsightly it impedes sight lines for drivers and is a safety risk for pedestrians. Current bylaws, allow residents to park a **licensed** vehicle for a maximum of 30 days on Village boulevards; however, during winter months with crews plowing snow this becomes an issue. Please park your recreational vehicles in appropriate driveways, yards or storage facility. The Village will be acting on by-law infractions and we ask for your cooperation rather than impose enforcement.

Also, please note, **living in an RV is prohibited in the Village of Ashcroft.**



Sidewalk Snow & Ice Removal

Pursuant to Bylaw No. 753, Ashcroft residents are reminded that it is unlawful for any person to permit any accumulation of snow or ice to remain upon any sidewalk in front of or abutting any premises owned or occupied by him/her after ten o'clock in any morning of any day.

Voyent Alert - Mass Notification System

One of the priorities from the previous strategic plan, was to purchase a portable digital sign; however, during a community survey, residents clearly said they prefer a automated telephone system to broadcast emergency notifications. As such, the Village has purchased the Voyent Alert system. Over the next two months, you will receive registration information to sign up for emergency notifications from the Village. Notices will be broadcast by land line phone, cell phone (text or message) and email. Stay Tuned for more info!
