Requests must be received by October 7, 2022 in order to receive Mail Ballots by mail. Applications received after 4:00 pm October 7, 2022 but before 4:00 pm October 13, 2022 must pick up Mail Ballot packages at the Village Office.
2. If your application is complete, the Village Office will send you a mail ballot package as soon as possible following the official Declaration of the Election.
3. You are responsible for ensuring that your completed ballot is received by the Chief Election Officer or designate by 4:00 pm Friday October 14, 2022 or on General Voting Day, Saturday, October 15, 2022 no later than 8 pm, close of voting.
