

COUNCIL NEWS

Council is pleased to report that the audit is complete and the Village of Ashcroft has received a clean audit. Shawn Birkenhead from Grant Thornton LLP presented the 2022 Audited Financial Statements to Council on March 27th which will form part of the Annual Report which will be published later this spring.

The primary focus this past month seems to have been on financial matters, Council will be hosting the annual Community Forum Tuesday April 11th at 5:00 pm in Council Chambers where CFO Bhalla will be presenting the draft budget to the public.

Later this month, most of Council will be attending the Southern Interior Local Government Association's annual conference in Vernon. The conference will be jam packed with information regarding current issues such as the housing crisis, planning and responding to climate related events and being a successful elected official. The conference is sure to engage council on many levels and provide information for many current issues.

Council passed the following resolutions in the month of March:

- \Rightarrow Council adopted Proclamation Policy No. C-02-2023
- ⇒ Council will establish an Accessibility Committee as per the BC legislated requirement. Half of this committee members will include persons with disabilities or are individuals that support, or are from organizations that support, persons with disabilities; at least one of the members is an indigenous person and the remainder of the committee will be comprised of two Council members and two staff members. This will be done following the development of a Terms of Reference Guideline
- \Rightarrow Council agreed to postpone the sidewalk construction on 3rd Street for one year. If parking conflict continues, the sidewalk construction will move forward
- ⇒ Anne McKague, a Butterfly Ranger of Butterflyway Beyond Hope BC presented to Council that April is Earth Month
 − Invest in our Planet
- ⇒ Council approved an advertisement be placed in the newspaper and on social media advising that Council is accepting applications for Board of Variance members
- \Rightarrow Council approved withdrawing as a member of the Gold Country Communities Society effective 2024
- ⇒ Council is in favor of moving forward with a Spring Clean up only and <u>cancel the Fall Clean</u> up moving forward this year.
- ⇒ Council directed staff to write a letter to HVC-Teck, CN Rail and Trimac expressing concerns raised to the copper concentrate dust in the area of Hollis Road; the requirement of a Fugitive Dust Management Plan for mining operations, request clarification if the plan includes the Hollis Rd. industrial site, and if included request a copy of the FDMP.



I would like to remind everyone about the importance of responsible watering procedures during the hot and dry months ahead. I have done some information gathering and realized that one of the best ways to stay on track when it comes to watering times is to purchase a water hose timer. They come in crank style as well as digital timers. The prices range anywhere from \$20 for crank timers to \$150 for multiple hoses. You can order them online or at your local hardware store (I checked). Thank you for your cooperation as we keep our watering to a minimum.

DOG RULES REMINDER

Keeping in mind that we are a small rural community where the lifestyle is a little slower and sweeter than in urban areas, man's best friend hasn't been so friendly. We realize that not all dogs are the culprits for the complaints, but if your furry friend roams the neighbourhood while on a walk

THE VILLAGE CREW IS ONLY ABLE TO COLLECT THE FOLLOWING:

Branches less than 8" in diameter & 8' in length; Leaves/Grass/Weeds/Twigs <u>(cannot be bagged);</u> Non-Refrigeration Appliances; Old Tires; <u>No</u> Construction Waste / House Hold Waste; Maximum weight of any single item or bundle is 100lbs.; The total weight per address is 1,000 lbs.; The total volume of material per address is 4 cubic yards (6' x 6' x 3'); Yard Waste must be out where it can be picked up by equipment; Yard Waste cannot be on Highway Right-of-Way; Yard Waste must be a defined pile on a level surface. Items must be kept separate (no mixing).

SPECIAL NOTES:

YARD WASTE <u>MUST NOT</u> BE AGAINST FENCES, SIGNS, BUILDINGS OR RETAINING WALLS OR IT WILL NOT BE PICKED UP. <u>STRICTLY ENFORCED</u>!!!

PLEASE DO NOT PLACE YOUR YARD WASTE OUT PRIOR TO APRIL 12, 2023. KINDLY HAVE YOUR YARD WASTE OUT TO BE PICKED UP ACCORDING TO THE ABOVE INFORMATION & SCHEDULE. THANK YOU.
