COUNCIL HIGHLIGHTS

Council met November 8th and 27th. Here are some highlights from those meetings:

- ⇒ Cpl. Denise Benfeld of the Ashcroft RCMP appeared before Council providing a policing update
- \Rightarrow Al Midgley, President of Bonaparte Watershed Society appeared before Council presenting his concerns regarding the Bonaparte Watershed and ongoing flooding situation. He is seeking grants available and other funding options
- \Rightarrow BC Dragit Challenge 2024 (BC's only Drag n Drive event) will be coming to Ashcroft June 23, 2024; they have requested a Railway Ave. road closure from 4pm to 8pm to host the event
- \Rightarrow Council approved a donation of \$1000 to Ashcroft's Christmas Hamper Fund
- \Rightarrow Council forwarded a letter of support to the Historic Hat Creek Ranch for an RFP to continue as operators of the site
- \Rightarrow Mayor Roden commented on the Ashcroft Honour Ranch's recent win of a customized Land Rover
- ⇒ Chris Rottluff of Dawson Road Maintenance appeared before Council & introduced Mohamed Hasani as the new Quality Manager for the area; as well he their winter program maintenance
- \Rightarrow Council approved a review of the current Ashcroft "Wellness Awaits You" brand during Strategic Planning and consider rebranding as a strategic priority
- \Rightarrow CFO Bhalla provided Council with a brief review of the Village's current financial position highlighting challenges, successes, and the inflationary impacts






PROPOSED DEVELOPMENT

At the November 27th Regular Meeting, Council approved first and second reading of OCP and Zoning amendment bylaw to allow a second apartment complex to be constructed at 1500 Government St. The amendment bylaws increase the density on the lot to allow the additional 37 unit complex. In addition to the bylaw amendments, a variance will also be considered to reduce the front and side parcel setbacks and reduce parking stall requirement to 1 stall per unit.
