The two major planning projects this year were the revitalization of the front end of Heritage Park and the complete upgrade of Mesa Park into a fully accessible and inclusive green space for the community. Grant applications have been submitted and we hope to begin the work next year.

The largest of our projects in 2023 was the renovation of the Fire Hall. The project is wrapping up, siding is being installed and the interior is at the deficiency stage. Once completed and the department has everything organized, Council will host an open house in the spring for everyone to come and see the improvements. Another project completed this year was the installation of the hot tub which was operational during the pool season much to the delight of the pool patrons.

There were many other projects and tasks completed as well as day to day operations, but through it all, our goal is always to provide excellent service in administration and operations for the Village.
