Watershed Stewardship for fish, fauna, wildlife, and all stakeholders

With this climate warming in our watersheds water conservation and storage should be prominent in all our minds. I believe and have been vocal in this idea for 15 years plus and believe we need to move forward with the implementation of water storage ideas and put action to the words. I purpose one or more trial areas as a test. The results should be seen in year one and two and following years should accumulate benefits. The background for these proposals follows as do how do we get it done.

What do we purpose?

We are getting faster melts and longer lasting summer heat thus longer drought periods and more fire risk. Our proposal is to slow the runoff from the upper watersheds by depositing gravel beds in the discharges of the upper meadows to slow this part of the watershed by several weeks. This dispersing of the water over a wider area would encourage plant growth, keep the ground cooler, increase plant diversity and increase carrying capacity of higher areas and ultimately reducing fire risk for several reasons, more deciduous growth, more feed on higher meadow and more water for grass and browse eaters.

The downstream benefits should be lessened streambank stress, less stakeholder anguish and cost from lessened flooding and less stress on municipal infrastructure in impacted flood plains thus less strain financially for all stakeholders.

And how do we get there?

Brenda our secretary and Bonaparte Natural Resources person is meeting with the bands of South interior to talk about these thoughts and to ask their support of this idea. I am a member of the BCWWA and EOCP and am forwarding this proposal to them. I am also forwarding this to the BC Cattlemen Association for their support. I will forward this to one of my contacts in the BC ministries for distribution to the ministry of forest, environment parks, Highways, Mines and Agriculture. I will also deliver this to the local Government's, MLA's, and MP's. I will send it also to the local logging companies for their support.

Our next move is meet as many of you as possible as soon as possible and move forward with a source of funds to get a test in place before spring 2024. Cache Creek is in dire need of relief from high stream flow effect, and I would like to offer the Bonaparte Watershed as a trial location at least in this area. The Okanagan and Shuswap are the other two areas that need this action as tests as well.

The First Nation people, the loggers and the range holders and administrators are probably the knowledgeable people to guide the distribution of meadow drainage control points so we need them in the discussion, and this can happen as soon as we have funding in place and permission to do the work.

I believe the mitigation funds are out there, the talent to do the job is there, and time is of the essence to move forward in Watershed sustainability.

The lack of rental housing stock in BC has been a focus for the provincial government for some time. To counter the crisis, the province is taking action to develop legislation which will empower municipalities to develop and enforce bylaws limiting short term rentals (STR's). The inflationary environment we are currently in adds an additional layer of complexity to the problem. STR's are in demand and earn more revenue for the homeowner than a long-term rental unit can. As such, much of the available long term rental stock has been shifted to short term rentals where property owners are registering with Airbnb, Vrbo, and other STR platforms as alternate revenue sources.

The new legislation requires the homeowner to reside at the STR's location where a secondary residence may be established for short term rental. This legislation eliminates the ability of investors to purchase housing stock for the sole purpose of short-term rentals.

At this time the legislation affects communities with a population over 10,000; however, smaller communities can be proactive by developing appropriate bylaws. For you information, in Ashcroft the current STR's are: 4 homes licensed, 1 unlicensed, 2 unlicensed apartments/basement suites, 2 unlicensed condos and 1 unlicensed room. The Bylaw Officer is working on bringing the unlicensed STR's into compliance by purchasing a business licenses. Moving forward we will continue to monitor the situation and if there is a steady increase in STR's a report will be brought to Council for consideration.

Ms. McKague appeared as a delegation to re-acquaint Council with the Butterflyway Garden initiative and to ask Council to consider several suggestions for future implementation. To begin the presentation Ms. McKague introduced Evelyn White who created and presented a short video of the Butterflyway Garden project.

Ms. McKague was pleased to advise Council that she has achieved Butterflyway project status in Ashcroft with 12 gardens established throughout the community, noting that she is now taking courses to achieve Pollinator Steward certification. Ms. McKague encouraged Council to utilize unused spaces in Ashcroft to develop additional pollinator gardens, commenting that pollinators are struggling to survive mostly due to mankind and a lack of food which is often linked to herbicides being used to control weeds among other unwanted vegetation. Ms. McKague implored Council to reconsider the use of herbicides in the Village of Ashcroft. In addition, Ms. McKague advised Rev. Linda LaGroix would be taking over as the champion of the Butterflyway Gardens.

Other items Ms. McKague encouraged Council to consider include:

- Establishing a committee to review Ashcroft's climate action goals. Mayor Roden commented that perhaps Council could consider implementing an environmental lens to be applied to all projects and plans moving forward.
- Advised Council that the best way to address climate change is to talk about it.
- Establish committee to develop better polies such as anti idling, pesticide control, urban tree program etc.
- Ms. McKague encouraged Council to plant trees, shrubs and other vegetation that are native to the area.

Clearly Ms. McKague is very passionate about climate change, its impacts on the environment and all living things. She encourages Council to set a new standard of operations, one that considers the environment and leads the community by setting a good example and develop policies and bylaws that reflect good stewardship towards reducing Ashcroft's carbon footprint.



Ms. McKague kindly forwarded a summary of her presentation, which is attached to this report.

As promised, I'm sending a follow-up letter to my presentation at the council meeting on Oct. 23/23. Thank you again for the opportunity to speak and be heard.

I wished to inform the council of the success of the Butterflyway Project. We've established twelve pollinator gardens in business, residential and civic properties. In doing so, we enhanced the environment and provided year round interest to the streetscape. Along the way, we've garnered substantial public support. All of the organizations alongside the gardens have agreed to support their vitality. They have become guardians.

Pollinator Partnership, the David Suzuki Foundation, The Ashcroft-Cache Creek and Area Rotary and the Ashcroft HUB have all provided substantial resources and support. Reverend Linda LaGroix (revlinda.stalbans@gmail.com) has agreed to adopt the role of Butterflyway Ranger and act as a points person for maintenance and expansion of the Butterflyway Project. Practicing stewardship rather than gardening purely for the human eye is a new and rapidly developing mode-- there will indubitably be hiccups and setbacks, but we're optimistic and fully engaged. We are also asking that you review your use of pesticides and herbicide to maintain appearances. Surely we can ask property owners to pull weeds or plant beneficials in their place. Dead plant matter is not attractive or beneficial. Posting pesticide signs on the chain link fence surrounding a community garden is not a good look.

You have a laudable plan for addressing the climate crisis, but it doesn't appear to be active. We ask that you establish a committee on the Climate Crisis, or better still as Mayor Barbara Roden suggested, establish a component on every committee that ensures that addressing the climate crisis is instrumental in all facets of village work.

And finally, please, please devise and initiate a tree planting practice. We should be planting 20 trees a year, in the Mesa Park, in the cemetery, in the pool park, in front of the village office, at the skate board park and hey, maybe even a street tree of two. I am certain that citizens would donate money and time to do so. <u>Tree Canada, of course</u>, is another funding source. We need the shade, we need the ecological benefits supplied by trees. We need the beauty and promise to the future that trees embody.

It seems that our brand has morphed from "Where Wellness Awaits" to "Ashcroft-Desert Oasis" Let's work together to make it so for all of creation.

The Northern Woods & Water Highway is recognized and signed in the provinces of Alberta, Saskatchewan, and Manitoba. It officially runs from Dawson Creek to Winnipeg across northern Alberta, Saskatchewan, and Manitoba. Our Association is striving to extend the highway's reach by going through the province of British Columbia and getting it recognized and signed with our name & logo. The acknowledgment by the British Columbia government would generate the opportunity to market the highway as the 3rd Trans-Canada Highway. This would enhance the tourism economy in all the communities along the highway, thus bringing opportunities and benefits to local businesses and residents.

The concept for the highway was formed in the mid-1970s as a holiday route and as a transportation passage for northern goods. Initially, a group of campers would travel from Dawson Creek to Winnipeg and return each year. The association was formed, and the three provinces recognized and signed the highway. This year, for the first time, the Province has also included the management of the McAbee Fossil Site in the RFP. McAbee was designated a Heritage Site by the Province in 2012. The successful RFP applicant will be managing both Historic Hat Creek Ranch and the McAbee Fossil Site for the next six years.

The Society's board of directors include both appointed representatives from Ashcroft, Cache Creek, Clinton and TNRD's Area E and Area I directors, as well as random members elected at its Annual General Meeting at the end of each year. Our membership is open to everyone.

Tourism in BC is still struggling to recover from the many shutdowns and group tour cancellations that were initiated by the Covid-19 protocols, and our region is still working hard to bring the tourists back. I am writing to inform the Village of Ashcroft and staff of an upcoming community consultation regarding School Trustee Electoral Boundaries.

School District No. 74's Board of Education is proposing changes to the boundaries of two Electoral Areas the School Trustees represent. We welcome your input, should you have any.

Consultation with Constituents

School District No. 74 is engaging in consultation with Rights-holders as well as constituents residing in Gold Trail. **We are soliciting feedback until November 17, 2023**. Information, including maps of the current and proposed boundaries can be found on our website at <u>www.sd74.bc.ca</u>. Constituents can provide input on our website, by email to <u>district@sd74.bc.ca</u> or by phone (1-855-453-9101).

Information on the Proposed Changes

The main benefit of this proposed change is that constituents will be able to vote for a School Trustee in the electoral area in which the students of the constituency are attending school. Specific changes include:

- Increasing the size of Electoral Area G(7) and expanding its boundaries to include Ashcroft Indian Band, Venables Valley and surrounding areas (areas are currently in Electoral Area E(5))
- Area E(5) would decrease slightly
- The Village of Ashcroft, which is currently in Area G(7), would stay in Area G(7)
- If accepted by the community, the proposed Electoral Area change would be **put in place for the 2026** election for School Trustees
- It's important to note this proposed change is **not related to boundaries of catchment areas** and will **not impact the location where students attend school**
 - This change only means some people vote for School Trustees in different Electoral Areas

Highlights of the Thompson-Nicola Regional District Board of Directors Meeting of October 26, 2023

Delegation: Healing Between Worlds

The Board heard a delegation from Ryan Deneault, CEO of Healing Between Worlds, who introduced his Kamloops-based venture which supports those suffering from addiction and offers training for Truth and Reconciliation.

Whistleblower Policy Amendments

The Board approved amendments to Whistleblower Policy 7.1.6 (previously named Disclosure Policy). The policy amendments ensure transparency and ease of use and understanding, which include updates to the policy name, reporting processes, and confidentiality. Read the report <u>here</u>.

Canada Community Building Fund

The Board approved the following allocation from the Canada Community Building Fund:

 \$263,500 to fund Phase 2 of infrastructure improvements at Smith Pioneer Park, located in Lower Nicola, within Electoral Area "M" (Beautiful Nicola Valley – North). Phase 2 of park improvements is expected to include a perimeter path, outdoor fitness stations, park benches, a basketball court, asphalt parking, and various landscaping additions. Household Hazardous Waste Receiving Facility

The Board awarded a contract to North-Wood Environmental Services for a maximum value of \$1,000,000 for a five-year term, for a year-round Household Hazardous Waste (HHW) receiving facility in Kamloops. Contract costs will be shared evenly with the City of Kamloops, and the City will reimburse TNRD for half of costs that are actually incurred. The TNRD will continue to operate collection services at all Eco-Depots for in-scope HHW materials, with unacceptable material being directed to the year-round HHW facility. Flag Protocol Policy

The Board approved amendments to Flag Protocol Policy 1.4.1, which enable flags of host First Nations to be flown at TNRD buildings. Read the report <u>here</u>.

Utility Systems Committee

RE: New legislation to support local government housing initiatives

Over the past week, I have introduced several pieces of legislation to support local governments to get more homes built faster while enabling updated and new tools to effectively fund the costs of infrastructure and amenities to support increased housing supply and growth. Taken together, these changes are critical to getting more of the right kind of housing built in the right places to provide homes for British Columbians.

Last week, I introduced Bill 44, to support communities to deliver the homes people need quickly by allowing small-scale multi-unit housing across BC. These homes, including townhomes, triplexes, and secondary suites, can generally be built in a reasonable timeframe and blend more seamlessly into neighbourhoods. The legislation will apply to many areas of the province, and we anticipate it will allow up to 4 units in single-detached and duplex zones (or 3 depending on the size/type of lot) and up to 6 units permitted in single-detached and duplex zones close to bus stops with frequent service. It will also allow secondary suites or an accessory dwelling unit on single-detached lots throughout BC.

Bill 44 will also speed up the approvals process by moving away from spot zoning to ensure more comprehensive upfront planning and zoning to meet current and future housing needs. The changes include using a robust, standard methodology for calculating long-term housing needs for all Housing Needs Reports to ensure consistency across the

province. Municipalities will also be required to update Official Community Plans (OCPs) and zoning bylaws to ensure their communities have sufficient land designated and zoned to meet long-term housing needs and continue to make these updates on a regular basis. The new legislation will also remove the option for local governments to hold public hearings for rezonings for housing projects consistent with OCPs.

Today, I announced new legislation, Bill 47, to support new housing to get built near highfrequency transit, and yesterday Bill 46, to ensure local governments have tools to collect amenity and infrastructure contributions outside of the re-zoning process.

Bill 47 will require local governments to designate areas near high frequency transit stations as 'TOD Areas.' TOD Areas are near SkyTrain stations and busy bus exchanges and are expected to be identified in 29 municipalities in BC. This is different from the 6-unit requirements in the small-scale multi-unit housing legislation which will focus on properties within 400 metres of bus stops with frequent service. TOD areas will include minimum levels of density, size, and dimension prescribed by regulation. Similar to implementing small-scale multi-unit housing requirements, local governments will have a comprehensive provincial policy manual to assist in making bylaw amendments consistent with the TOD legislation. Off-street parking spaces in TOD areas will be determined by the market; local governments will not be able to require off-street residential parking, other than spaces for other uses like commercial, spaces for disabled persons and loading spaces. These changes will help get more of the right kind of housing built in the right places to provide homes for British Columbians. A subsequent letter will notify the identified municipalities in December.

The new legislation will expand the scope of infrastructure for which Development Cost Charges (DCCs) can be collected to include fire protection facilities, police facilities, and solid waste facilities. It also allows local governments to collect DCCs for provincial highway infrastructure projects where there is a cost-sharing arrangement between the municipality and the Province.

The new Amenity Cost Charges (ACCs) tool will allow local governments to collect monetary and in-kind contributions for amenities (e.g., community centres, recreation centres, libraries) to support liveable communities in areas where new housing is going. This tool will provide certainty and transparency for local governments and developers.

We are aware that local governments require tools and supports to facilitate the delivery of affordable housing in their communities. We are currently exploring policy options and additional tools, including the potential for inclusionary zoning, and I look forward to sharing more about this in the coming months.

I know that the new housing initiatives announced over the past week will take work to implement and require additional resources for your local government to meet the requirements. We have committed to \$51 million in funding for local governments to support planning and capacity to meet these new requirements. The funding will be allocated based on population and the volume of work needed because there are different requirements for municipalities and regional governments. The funding will be distributed in early 2024.

The Province has also provided another \$10 million for a second intake of the Local Government Development Approvals Program (LGDAP), managed by the Union of B.C. Municipalities (UBCM). This funding is in addition to the \$1 billion provided to local governments through the Growing Communities Fund to support the delivery of infrastructure projects needed to support increasing density.

The Ministry of Housing is committed to working together and supporting every community as we move forward with new approaches and new ways to deliver the housing supply our province needs. In the coming weeks, we will be providing policy manuals detailing the site-level specifications for small-scale multi-unit housing and TOD areas. Further guidance will be coming in the new year to support implementation of the development finance tools and pro-active zoning requirements. Ministry of Housing staff will be in touch with your administration in the coming weeks to provide more detail about the changes and about funding and educational support and opportunities.

Kamloops, BC – November 10, 2023 – During the inaugural Board Meeting of the Thompson-Nicola Regional District (TNRD) held on November 9, 2023, Village of Ashcroft Director Barbara Roden was acclaimed as Board Chair, and District of Logan Lake Director Robin Smith was acclaimed as Board Vice-Chair.

During a call for nominations, only one nomination was made for the positions of Chair and Vice-Chair, resulting in the acclamation of these positions.

"It's a great honour to have my fellow directors put their trust in me for another year, and I'm very happy to be working again with Director Smith as Vice-Chair," Roden said.

"The last year has been a learning curve for the two-thirds of the Board who were newly-elected in 2022, and for me as Chair. It's been very exciting to see all the energy and ideas from this new Board, and to develop a new Strategic Plan. I'm looking forward to seeing some ongoing projects completed, and starting to work on new projects that have been identified as key, including emergency planning and preparedness, accessibility, a new library for southwest Kamloops, and building relationships and partnerships with First Nations."

Roden continued: "In my first year as Chair, I committed to rebuilding trust with residents of the TNRD. Along with Vice-Chair Smith and the rest of the Board, I will continue that rebuilding work, to ensure that the TNRD lives up to its name as the Region of BC's Best."

Kamloops Residential Real Estate Market Activity Lower than Usual

KAMLOOPS, B.C. – November 3rd, 2023. Residential real estate market sales are below average for October as high interest rates continue to dampen market activity, reports the Association of Interior REALTORS[®] (the Association).

A total of 977 residential unit sales were recorded across the Association region in October marking a slight increase over September's 977 units sold and representing a modest 1.8% decrease in sales compared to October 2022.

New residential listings increased 8.6% compared to October 2022 with 1,971 new listings recorded. The total number of active listings saw an increase of 17.1% of total inventory compared to October last year with 7,399 recorded across the Association region. The highest percentage increase in active listings continues to be in the South Okanagan with a total increase of 37.7% and followed closely behind in the North Okanagan with a 26.6% increase in active listings compared to the same month last year.

"While we typically do see market activity ease up as the weather cools, the high cost of borrowing seems to be propelling a speedier seasonal slowdown than usual," says the Association of Interior REALTORS[®] President Chelsea Mann, adding that "buyers and sellers are left waiting in the wings despite high demand with the hope of seeing some interest rate relief on the horizon."

"The impact of qualifying for mortgages seems particularly impeding to rate-sensitive buyers as they struggle to secure financing. It is more important now than ever that buyers get pre-approved ahead of their house hunting efforts to ensure their expectations can align with their needs," says Mann.

Within the Kamloops and District region, there were 175 residential unit sales recorded last month, down from the 183 recorded in September2023 yet up 6.7% from October 2022's unit sales.

There were 357 new listings recorded in October in the Kamloops and District region, which was an increase of 10.9% compared to the same month last year, and down from September 2023's 429 new listings. Overall inventory, or active listings saw an increase of 13.2% compared to October 2022, coming in at 1,021.

"Although unit sales in Kamloops and District are up compared to October of last year, sales activity is below the average for this time of year as tough mortgage qualifying rates continue to mute buyer demand," says Mann.

The benchmark price, a better representation of value compared to the average or median price as it represents a dwelling of "typical attributes", saw increases in the single-family and condominium housing categories compared to October 2022, with 1.7% and 7.8% increases, respectively. The benchmark price for town homes decreased 2.0% in year-over-year comparison, coming in at \$539,200.





Your Worship,

I write today to raise concerns from our shared constituents over jurisdictional responsibilities related to the Cannabis Act. Since I was elected, I have been advocating for the federal government to empower provinces and municipalities with the resources required to enforce the Cannabis Act regulations downloaded upon them.

Currently, the Cannabis Act is undergoing a review as mandated by legislation three years after it was enacted. I am pleased to have sponsored House of Commons' petitions started by constituents calling on the federal government to address major gaps in cannabis regulations. Better information sharing is needed between Health Canada and law enforcement to ensure police have accurate and readily available information on licensed producers. Provincial and local governments are expected to manage excessive noise complaints, illegal dumping, odor, pollution and fire safety; however, they are often blocked from exercising authority when it comes to licensed producers for medical purposes. Health Canada needs to recognize this quagmire of responsibility and empower local governments.
