**SUBJECT:** Increase Scope of 2021 Paving Project

---

### Purpose

To request Council approval to increase the scope of the paving project due to lower than anticipated costs.

### Recommendation

That, Council approves to increase the 2021 Paving budget to \$100,000

### Alternatives

### Discussion

In 2020 the paving budget was \$35,000; this work was not completed as the paving contractor was unable to schedule Ashcroft into his rotation. The \$35,000 remains allocated in the 2021 budget with an additional \$35,000.

The quotes received from the current paving contractor in the area are very cost effective and PW recommends that the budget be increase by \$30,000 to a total paving budget for 2021 of \$100,000.

The areas scheduled to be paved/patched are:

- Cariboo Rd – Government -Ranch intersection (including widening the road by 6 feet)
- Riverview Crescent – River Inn Hill
- 9<sup>th</sup> Street to Cemetery
- 1<sup>st</sup> St. to just past 2<sup>nd</sup> St on Railway Ave
- 1<sup>st</sup> to 2<sup>nd</sup> on Brink St.

If approved, there may be opportunity for further sections to be paved dependant on final cost estimates.

The paving budget increase would be allocated from the additional Gas Tax Funding for 2021.
