

Monthly Review FEBRUARY 2025

COUNCIL HIGHLIGHTS

Council met February 10th and 24th. Here are some highlights from those meetings:

- ⇒ Cam Tedford appeared as a delegation regarding, funeral costs/cemetery space & opportunity for our village lost; question of different options for space: Mesa cemetery implementation, ground penetrating radar to the back area of the cemetery to determine additional burial sites
- ⇒ Council adopted the amended Travel Reimbursement Policy No. F-03-2021
- ⇒ Council issued a "Notice of Intent" to consider approval of a Development Variance Permit Application for 710 Elm Street; neighbourhood notification was sent out to property owners within 100m of the subject property to advise consideration of the proposed Development Variance Permit
- ⇒ Council approved the engagement of Holistic Emergency Management Preparedness and Response (HEMPR) to conduct a review and update of the Village of Ashcroft's Emergency Response Plan (ERP), ensuring full compliance with the Emergency and Disaster Management Act (EDMA) and Indigenous Engagement Requirements Funding Program (IERFP); Administration was authorized to sign a contract with HEMPR for these services within the grant-funded budget of \$40,000, ensuring the necessary updates and training are implemented effectively
- ⇒ Council approved the purchase of a 2016 Morgan Freightliner Tanker for the Fire Department at a cost of \$194,000 plus applicable taxes
- ⇒ Council fully supported the submission of an application to NDIT Marketing Initiatives funding stream seeking financial assistance up to \$19,275
- ⇒ TCMHA's request to address key issues at Drylands Arena was referred to the Parks and Recreation Working Group
- ⇒ The Ashcroft 4-H Club was approved to use the Community Hall the 1st Tuesday of every month in 2025 and for their various events
- ⇒ Council approved the HUB's request to provide a letter of support for capital grant applications to replace the roof and HVAC System
- ⇒ The Policy Review Committee has completed the review of all policies
- ⇒ Economic Development & Tourism Coordinator's report indicated the new village website is set to go live the first week of March
- ⇒ Council approved Railway Ave closure from 10am-noon April 19th for the Rotary Club sponsored Spring Parade
- ⇒ Council approved the Housing Needs Assessment Implementation Strategy
- ⇒ Council approved submitting a funding application to UBCM's Emergency Operations Centers Equipment and Training Fund for the EOC Development Project in the amount of \$40,000
- ⇒ CFO Bhalla verbally reported on Preliminary Budget Revision Update
- ⇒ Council directed staff to develop a new category for utility fees that is suitable for non-profit organizations such as the Ashcroft HUB
- ⇒ Mayor Roden advised that with the TNRD Hospital Budget 2025 the Ashcroft UPCC is budgeted to receive a Bariatric bed—\$24,100, Bladder scanner—\$21,600, Vaccine refrigerator—\$12,300 and an emergency generator upgrade—\$1,590,000; TRHD will pay 37% of the costs listed
- ⇒ The speed survey results indicating the community is in favour of reducing the speed limits to 30 km/h throughout the community will be included on the next Town Hall Meeting
- ⇒ Councillor Clement reported that HAWK is working on a follow up survey to the one completed in 2022. This will focus on the UPCC and its use as well as people's perceptions of it
