#### **POLICY MANUAL**

Policy No. 8 Page No. 1 of 1

#### RE: YOUTH AT UBCM POLICY (updated May 9, 2019)

#### POLICY STATEMENT:

It will be the policy of SILGA to reimburse up to 2 youth each year for the cost of travel, accommodation, meals and out of pocket expenses incurred to attend the UBCM convention.

#### POLICY BACKGROUND:

To promote youth involvement and interest in local government, SILGA will annually sponsor up to 2 youth to attend the UBCM convention. A call for nominations will be sent by SILGA after each annual convention to all SILGA members with the youth representatives chosen at the SILGA executive meeting on June 19, 2019. Deadline for nominations for 2019 is June 17<sup>th</sup>.

A SILGA member local government must first nominate a youth from their community. A brief statement written by the youth explaining why they want to attend along with a summary of their interests and accomplishments should accompany the nomination.

The local government of the selected youth will mentor them during the week of the convention. The youth will be requested to provide a written report to SILGA outlining their experiences and the impact the week had for them.

#### Definition of "Youth"

- School age secondary students registered in a public school, an independent school,
   Distributed Learning program or as a home-schooled learner
- up to the age of 19 on or after July 1 of the current school year

SILGA will spend up to \$5,000/year for the cost of this program. Receipts will be required. Sponsoring local governments are requested to cover the allocated conventions costs for the selected youth and then submit receipts to SILGA for reimbursement.

#### **POLICY DETAILS:**

- 1. Transportation:
  - To pay compensation for air travel at the lowest available air fare; or
  - To pay compensation for the use of private vehicles at the rate equivalent to that paid by the Province of British Columbia<sup>1</sup>, to a maximum of the lowest economy air fare.
  - Only the driver is entitled to reimbursement for car mileage; the driver must submit the names of the passengers with the expense account.
- 2. Accommodation (due to weather conditions/distance travelled/ other circumstances):
  - To pay compensation for hotel rooms at cost and with a receipt required; or
  - allowance of \$30.00 per night may be claimed (no receipts required).
- 3. Other Expenses:

 For all meetings and other authorized travel where required meals are not provided at the event, compensation for meals will be as follows:

> Breakfast \$15 including tips and tax Lunch \$25 including tips and tax Dinner \$35 including tips and tax

On the date of departure, travel must start before 7:00 am to claim breakfast; before 12:00 noon to claim lunch; and, on the date or return, travel must end after 6:00 pm to claim dinner.


 All other expenses occurred for hospitality expenses and other nonspecified expenses shall be reimbursed at cost when receipts are provided, subject to Executive approval.

#### REVISED Information Bulletin 04 - Cannabis Production in the ALR

The Cannabis information bulletin has been revised subject to changes in the ALR Use Regulation. The changes clarify that all forms of cannabis production are a "farm use" that does not contravene the ALC Act even if engaged in without ALC approval, with some exceptions related to soil removal and fill placement.

#### REVISED Information Bulletin 05 - Residences in the ALR

The ALC has revised the definition of Total Floor Area to exclude attached garages/carports less than 42 m<sup>2</sup> from the calculation.

**Dear Local Governments:** 

As you are aware, housing availability and affordability are some of the biggest issues facing British Columbians today. That is why I am writing to let you know about exciting partnership opportunities that can be used to increase the supply of affordable housing in your community.

With the 30-point housing plan, the Government of British Columbia is making the largest investment in housing affordability in B.C.'s history—approximately \$7 billion over 10 years—through the **Building BC** funds. In the first year of this plan, we have already made significant investments in communities across British Columbia:

- Building BC: Community Housing Fund (CHF) will provide close to \$1.9 billion over 10 years to develop 14,350 units of mixed income, affordable rental housing for independent families and seniors. The new homes are designed to address the need for affordable housing across a range of income levels, in response to a housing crisis that has made housing unaffordable for even middle-class families. Currently, more than 4,900 of these new homes have been approved in 42 communities. - Building BC: Indigenous Housing Fund (IHF) is a \$550 million investment over the next 10 years to build and operate 1,750 new social housing units for Indigenous families and seniors. In Fall 2018, we announced 1,100 new affordable homes for indigenous peoples in 26 communities across B.C. (See news release for project list: <a href="https://www.bchousing.org/news?newsId=1479152910395">https://www.bchousing.org/news?newsId=1479152910395</a>)
- Building BC: Women's Transition Housing Fund (WTF) is investing \$734 million over 10 years for 1,500 units of transition and second-stage housing to help women and children get out of violent and abusive situations and rebuild their lives. More than 280 of these new spaces have been approved for 12 communities.

- Building BC: Supportive Housing Fund (SHF), an investment of \$1.2 billion over 10 years, will deliver 2,500 new homes with 24/7 support services for people who are experiencing homelessness or who are at risk of homelessness. This fund builds on the *Rapid Response to Homelessness initiative* (now fully subscribed) in which 2,000 homes with supports are currently being built in 22 communities across the province, with 1,285 units already opened.
- Building BC: Capital Renewal Fund (CRF) is a \$1.1 billion investment over the next 10 years to make existing B.C. social housing stock more livable, energy-efficient, and safer. This investment will make dramatic improvements to the existing social housing stock in the province and benefit thousands of British Columbians.

Many of these housing projects are underway, but I wanted to make sure you knew about upcoming opportunities to apply for future funding. BC Housing is interested in partnering with municipalities, non-profit housing providers, and community groups to create more innovative and sustainable housing solutions through the following:

- Future RFP BC Housing will be issuing a second formal Request for Proposals for the
   Community Housing Fund and the Indigenous Housing Fund in 2020. We encourage groups
   interested in submitting proposals to start their planning early, to ensure their projects are







SUBJECT: EMERGENCY DEPARTMENT CLOSURES - ASHCROFT HOSPITAL

#### **Background**

Interior Health advised the community on Thursday, May 16 that the Ashcroft Emergency Department (ED) would be closed for two 8 hour shifts; one on Saturday, May 18 and one on Sunday, May 19. This is the fifth time the ED has been closed in 2019.

#### **Discussion**

Historically the ED has been closed occasionally due to illness, absence of physicians or nursing staff however in recent years these closures have been relatively few and far between.

The community is expressing concerns at the lack of service being provided at the ED and that it can no longer be relied upon for being open, especially during long weekends. The public appears to be losing confidence in the system.

Administration, and I am sure Council, have heard comments that the recent closures are due to retirements of nursing staff who were full time and lived locally. We have also been advised that the postings for replacement nursing staff are now less than full time positions which makes it difficult to attract people to fill the vacancies.

Council has sent a letter to Susan Brown, IH President and CEO, requesting to meet and discuss the local services and we were advised that our request was forwarded to her staff to include us in her next visit to this area.

Administration suggests that Council may wish to contact Ms. Brown and express concerns for the increasing number of ED closures and request a meeting to discuss the situation. As Ms. Brown is located in Kelowna, a delegation of Council could easily travel there to meet with her if necessary.

#### Recommendation

Staff is providing this memo to Council for information purposes and suggests that the following motion may be appropriate:

THAT Mayor Roden contact Ms. Susan Brown, President and CEO of Interior Health, and request a meeting to discuss the increasing number of Emergency Department closures and other concerns relating to health care within Ashcroft and area.

Highlights from the Thompson-Nicola Regional District Board of Directors' Meeting of May 16, 2019

The Current May 17, 2019

#### Public Hearing: Zoning Amendment Bylaws No. 2665 & 2679

A public hearing was held for a zoning amendment to allow for a commercial cardlock facility in Monte Creek. Another public hearing followed for a zoning amendment that would allow cannabis retail sales in an existing shop in McLure.

No public input was received for either of these proposed amendments and the bylaws were read a third time by the Board. This will not proceed to Ministry approval before returning to the Board for adoption.

#### Zoning Amendment Bylaw 2678 Repealed and Amended

At the April 18<sup>th</sup> Board meeting, the Board engaged in a debate around the rezoning of land near the Boston Flats community near Cache Creek to enable an eco-depot. Given the contention around this matter, it was recommended that Bylaw No. 2678 be amended to remove the rezoning and proceed back through the process for the cannabis and ALR related contents of the bylaw. The Board approved and the bylaw will be taken to a public hearing.

#### Community Water System Bylaw Adopted

To aid in water conservation and management of infrastructure, the TNRD will be installing water meters in all 11 community water systems owned and operated by the TNRD over the next couple of years. The Board was given a report summarizing the major changes proposed in the new Community Water System Bylaw No. 2683 which will provide for better regulation of existing water usage. The bylaw was read and adopted by the Board.

#### **Notice Enforcement Bylaw Adopted**

In conjunction with the adoption of the Community Water System Bylaw, the Board approved an amendment to Notice Enforcement Bylaw No. 2500. Each time a regulatory bylaw is adopted (or amended) that includes penalties for violations through ticketing, a complementary amendment of this bylaw is required to establish those penalties. #### Gas Tax Funds

The Board approved the following requests for Federal Gas Tax Funds:

- \$24,000 to Electoral Area "A" (Wells Grey Country) for Phase 2 trail development of the Candle Creek Mountain Bike Trails Network
- \$15,000 to Electoral Area "J" (Copper Desert Country) for electrical upgrades at the Savona Community Hall
- \$60,000 to Electoral Areas "L" (Grasslands) and "P" (Rivers and the Peaks) for <u>access</u> <u>improvements to the Prichard Community Hall</u>
  - o \$30,000 will be allocated to each Electoral Area
- \$5,500 to Electoral Area "O" (Lower North Thompson) to install a <u>new irrigation system for the Barriere & District Riding Club arena</u>

In addition, Director Rothenburger moved that \$250,000 be transferred from the Electoral Area "P" Gas Tax allotment into the pooled Gas Tax account. The TNRD Board is grateful for this shared resource which will allow the funds to be available for use in other Electoral Areas as needed.
